

# 2011 Queensland Sanction Fee Structure



A sanction fee of \$2.20, \$3.30 or \$4.40 (GST inclusive) per player per event depending on the ranking points allocated to each event must be paid to Tennis Queensland within 7 days of the completion of the tournament.

Please note that \$3.30 and \$4.40 sanction fees only apply to events of a certain ranking point category.

## PLEASE STUDY THE TABLE OF FEES CAREFULLY BEFORE SUBMITTING YOUR TOURNAMENT SANCTION FEES

Applicable sanction fees per player per event in 2011 are as follows. Please note all amounts are inclusive of GST:

Silver, Bronze and White Australian Ranking Points	\$3.30 per player per event
All mixed doubles events	\$2.20 per player per event
All other singles events (grade, specials etc)	\$2.20 per player per event
All doubles events	\$2.20 per player per event

<b>Ranking Level</b>	<b>Sanction Fee</b>
All Australian Ranking singles events	\$4.40 per player per event
All other Junior singles events	\$2.20 per player per event
All Junior doubles events	\$2.20 per player per event

<b>35+ SENIORS TOURNAMENTS</b>	
All singles and doubles events	\$2.20 per player per event
